Locking workflow settings can be set to the lowest number and set the EMS incident status upon lock = BLANK. The "Audit Tracking Reasons" asks the user why they are 1-viewing the existing record 2- updating a record 3- updating a finished record 4-completing a bulk action all with prompting the user to enter a reason in a text field. Field Level Audit is tied to LOCKING (starts upon LOCK) not to finish incident settings or posting. Motion Bagdade: Incidents should LOCK on POST with the EMS user having the ability to unlock a report so that Field Level audit could track any changes made to the report, and the ability not to have to contact the admin. to unlock a report. Then the report would re-lock automatically after 1 hour. Audit Tracking Reasons will NOT be used. Motion 2 nd Rill: Discussion continued with some clarification on the motion then voted "Yea" unanimously.
