Education Activities Reports	 EMT Class (Chris) –Numbers have increased. Started with 52 students and are now down to 43. Class redesigned to use more discussion/lecture format and include gaming options when applicable Paramedic Class (Bill)- 32 students in this newest semester. The paramedic program will utilize the same format as the EMT program CE Reports – (Kourtney): new CE focus is more participation. 7/10 classes will include a skill focus. The aim is to facilitate competency in skills training System Entry testing and Peer Educator credentialing (Kourtney): going well. There is an organized schedule but private testing is available if the current schedule does not meet the needs of the department. There are usually 8-12 candidates per session ECRN class (Connie) - hybrid model will continue TNS class (Connie) – hybrid course hosted in McHenry Peer Educator Project Group (Kourtney): the data base for peer educators is being finalized. There are a few departments that need to submit their peer educators. The process for reverification of Peer 1 and 2 educators is outlined in the Peer Educator policy. The main focus of the peer educator's project group is still focused on creating a mini library, mini modules, and collecting any other training materials that departments are willing to share. Alternate Chair (provider or hospital): still needed.

	 Training: both in CE and at the departments adequate or is revision necessary? What training is being provided and assessed? Example: first pass intubation success rates are declined over the years
	Root cause analysis is more complicated since there are multiple reasons for the changes in overall system performance. The potential reasons were broken down into large subgroups. The goals and expectations for the project were outlined. For the Education Committee, the two main focus areas are:
	 Education/retention: reviewing the education being offered and identification of reasons for gaps between eduction provided and retention of that information. Interested individuals should contact Karin
	 Skills/competency: best model for verification of skills competency by system members. Process will begin with the peer educators to ensure they are teaching/testing skills appropriately. Interested individuals should contact Tina. Tina will partner with Kourtney and the peer educators
