R&D	Glucometer roll-out – Have found several causes for error readings:  . Manufacturing flaws in strip die cuts (corrected) . Company did not inform us of recalls of 25 strips/bottle as they didn't think . Meter failure: Unexplained – replaced immediately . User error in meter mode used at testing – more frequent problem  Daily testing continues. Price reduction \$1/bottle in place. Company changing the requirement for professional use. Continue vigilance re marking 90 day exp dates of ECG electrodes: Multiple instances of Zoll monitors not reading ECG due to dried with large packs of leads (usually after-market brand). Each hospital asked to look Zoll leads never fail; neither do one other brand (uncertain which one). Need smalled closed tightly. Solution?	eir marketing materials to reflect daily testing of strips and testing solution once opened. out (poor quality) ECG leads. Only happens at the type and brands of leads exchanged.

State news	Updated EMS Rules approved by JCAR (July) and posted to state EMS website (Sept) – hundreds of pages of changes!  Education/QI provisions of updated EMS strategic plan unanimously approved 10-22-18 by State Education committee – Illinois will transition to NREMT testing for entry level graduates in Jan 2023.  Site code submission checklist under new EMS Rules also approved Monday. In effect now. Resources being shared with programs needing assistance on syllabi; lesson plans; schedules, etc.  Tutorials coming for BLS skills now part of EMT scope of practice  Tutorials being discussed for EMS Educators to maintain LI licenses  Planning for electronic only System plan updates – templates for all contracts coming from IDPH – no customization. Will be asking for education plans and updated protocols first.  Planning for System site visits to restart.
