Old Business a. 2018 Sepsis screen b. 2018 Ketamine screen	<ul> <li>a. 2018 Sepsis screen – There are 39 runs that had SBP &lt; 90 and no Norepi given. Jason will continue to review these calls and gather conclusions to present at next month's meeting. These numbers will help us establish a baseline that we can improve upon.</li> <li>b. 2018 Ketamine screen - Jason handed out the screen results. Total of 21 patients (most given for excited delirium – 3 were for other). Some discussion about the dosing. At the region level they are concerned we are potentially overdosing; however, our data shows we are consistently under-dosing. The goal of the SOP is to dose them until they are sedated, and not overdose (or fill the entire dose if they are sufficiently sedated before the full dose is met). Much discussion about how a pt. can fit into multiple protocols and that we should be aware of the contraindications for the medication we give. We need to get better at looking at the whole picture to decide if there can be other differential dx that fit for this patient. There were 7 calls that were listed as having an "emergence rx" so we looked at those 7 as a committee and decided the pt. truly did not display any s/s of an emergence rx, so we will adjust our data accordingly. Some discussion about how to update the SOPs to make them more user-friendly for this patient population.</li> </ul>	Jason will continue to look at the runs that had SBP < 90 with no Norepi given and bring data to next month's meeting.
New Business a. Updated screen schedule b. 2018 Q3 Naloxone screen	<ul> <li>a. Updated Screen Schedule – Jason presented the updated screen schedule for the remainder of this year. Some changes made to reflect upcoming education as well as regional data. Regional level trying to get a data analysis group underway, so they are starting with each system presenting some data. Our system will be presenting advanced airway information in December; therefore, PBPI will pull these numbers in November.</li> <li>December is an open month so we will do a stroke screen that month since we have not done one in a while. The hospitals will provide data on confirmed stroke patients, and Jason will then tailor our screen based on that information. Additionally, we will pull the EMS calls that we thought were strokes (and ended up not being), to see what other s/s might have pointed us toward a different diagnosis.</li> <li>b. 2018 Q3 Naloxone Screen – this month is going to be our Q3 naloxone screen. Jason will email out the screen and the instructions. Please complete by end of month and send back to Jason.</li> </ul>	Return Narcan data to Jason by end of October.
