Decompression Needle (Z. Way, BCFPD)	Decompression needle from Cardinal Medical is a 4" long 8G Turkle Needle. The main advantage is that it lets the user know when they are in the plural space. It has an indicator that turns from red to green. The catheter is also non-kink and it has a stop cock attached to the unit. Pricing is around \$60 per unit.	Dr. Jordan expressed interest and Zach will set up a rep to visit and demo the device at the next meeting in March.

Binder Lift (L. Walker, WDFD)	Binder lift system was presented which consists of a belt and leg strap for lifting patients. There are two sizes a standard \$ 700 and a bariatric \$ 800. B. Lee LZFD say that they have been using device for 2 years and the committee had approved it. The only lifting device on the drug and supply list is the Mangar Camel which is an optional piece of equipment.	S. Wood NWCH said that she would get a determination if every lifting device needs to be approved and have a training program written up for it, and then added to the drug and supply list.
Water-Gel Burn Kit (T. McIntyre, HEFD)	Presented by Taylor it is a burn sheet that aids in cooling and protecting the burns. It is currently used by Com ED. You can purchase as a kit or buy the individual sheets.	Further discussion on this product will be tabled to March and more information will be given.
Open Session	S. Renshaw presented the Go-2-Vent. It is an oxygen powered ventilating device, operated on 15 liters of O2, that is single use, except for a monitoring device that is reusable. It cost around \$110 compared to a Zoll ventilator that is around \$10,000 new or \$8-9,000 refurbished. Cost of reusable monitoring device is \$500. Currently it is in the testing process and is not approved for use with active CPR.	Interest was expressed by committee and Scott will set a vendor presentation for next meeting in March.
