After what amounted to a five-month interview, Chris Dunn was selected from four System medics who worked with Pete Dyer and Bob Kolder during the spring EMT-B class to succeed Bob as the EMT-B class Coordinator. Pete Dyer will be taking a one-year sabbatical, so Chris will assume the day-to-day responsibilities for class operation. For the first time in our history, the number of EMT-B applicants has filled two classes for this fall, so Chris will be ably assisted by two of the other mentees, **Kris Mullen** (LGFPD) and **Adam Rothenberg**, (PHTsFPD) as lead instructors for the respective programs.
