As many of you know, **Advocate Lutheran General Hospital** was recently approved by IDPH as a **Resource Hospital**. Their current EMS team remains intact and Robyn Mazzolini will be their new EMS System Coordinator. They will officially begin operations at the end of July with five Provider Agencies that are joining them from the St. Francis EMS System in Evanston.

With this new designation, LGH will no longer be an Associate Hospital of the NWC EMSS. However, they will be using the Region IX SOPs and plan to maintain ECRN education and competencies that are equivalent to the Northwest System, so we have delegated on-line medical control (OLMC) privileges to them for any NWC EMSS Provider Agency who is transporting to their location. They remain the Level I Trauma Center for Region IX. This means that there is **NO CHANGE** to current policy with respect to **selecting a receiving facility** or **calling LGH directly for OLMC** if you are transporting to them. They will continue to stock and exchange the supplies on the NWC EMSS Drug and Supply List.

What is changing?

- Robyn will no longer be fulfilling the duties of an Associate Hospital EMSC in our System. In part, this means that she will not be conducting in-station classes for us as she will have her hands full with the educational responsibilities in her own System. Robyn has done a fabulous job for us and we cannot thank her enough for her diligence and support for many years. We very much look forward to continuing our relationship with her in her new role and wish her all success.
- The two NWC EMSS Provider Agencies previously assigned to LGH have been reassigned. Susan Wood is delighted to accept oversight of Superior Ambulance Service and Connie is excited to be working with the Des Plaines Fire Department. Personnel files have already transitioned to the NWC EMSS office and members of these agencies are encouraged to call or e-mail Susan or Connie any time they have questions, comments, or concerns. Both will be coming out to meet members of each agency in the near future. See the System Directory for contact information.
