# Policy L2 Safe Ambulance Operation Use of Lights and Sirens updated

The System Advisory Board and the Chiefs/Administrators have approved and endorsed the attached update. New language provides clear direction on what is authorized when responding to a scene and during transport including the need for OLMC authorization in some instances. It incorporates best practices from multiple position papers and includes relevant clauses from Illinois law.
