MPR	@0944	<p>***Suggestion – To remove COVID from “Signature Reasons” & “Signature Status” values and leave what was existing pre-COVID.</p> <p>Displayed the MPR form and how it would work on the scene in accordance to the R-6 policy. There were questions on the usage of the MPR with special cases of minors and MOI. If the EMS provider on scene has a reasonable suspicion that there could be an injury due to the significant mechanism then that PERSON now becomes PATIENT. If a minor is on the scene with parents able to provide consent, then the parent would initial for the child.</p> <p>There was a suggestion to create a visibility rule or a preset value to guarantee a user to always document correctly. This idea will be looked into and brought to the April meeting. Further discussion provided the Chair with multiple suggestions in order to make documentation as user friendly along with assuring consistency in documentation.
