Ambulance specs

We were rapidly able to get an answer from IDPH yesterday, that the newly published emergency rules had a slight error in the section about ambulance specs. Leslee Stein Spencer is getting new rules ready to go to correct the oversight. In the meantime, here is her response to us: "The new rules that we are working on will say the following: Each new vehicle used as an ambulance shall comply with the current criteria established by nationally recognized standards such as National Fire Protection Association, Ground Vehicle Standards for Ambulances, or the Federal Specifications for the Star of Life Ambulance." For those of you urgently trying to spec ambulances in advance of hefty price increases, you are good to go using the KKK specs!

**Supreme Court** decision on vaccine mandates and IDPH response to our question about applicability to EMS here

For those of you that receive Page, Wolfberg, and Wirth messaging, you got the following email yesterday: "CMS Vaccination Mandate: Hospitals and other facilities covered by the rule will now be required to ensure that all employees and "individuals who provide care, treatment or other services" for the facility "under contract or other arrangement" are fully vaccinated or properly meet a religious or medical exemption. While the CMS vaccine does not directly apply to EMS agencies, your agency may soon be asked by these facilities to ensure that EMS agency employees entering those facilities are fully vaccinated from COVID-19 or meet one of the exemptions. PWW believes that this requirement should not apply to EMS agency personnel entering covered facilities for 911 emergency responses.

IDPH was asked for an interpretation from their legal department regarding what this may mean for EMS in Illinois. Here is their response from early this am:

"First, this is a legal interpretation that appears to be directed at those who PWW represent. EMS are defined as healthcare workers in our rules and if they are contracted to do work for a hospital such as interfacility transport then that hospital can require vaccination or whatever else they want.

Our EMS rules are still in effect and therefore all EMS providers public or private should be vaccinated or tested. Hospitals should however not prevent entry for those bringing patients in to the ED for care. They (hospitals) should rest on the notion that all EMS provider agencies are following the rules of vaccination or testing of their personnel."

Temporary Paper PCR	The updated IDPH Emergency EMS and Trauma Center rules allows EMS Systems to create and approve temporary Paper PCRs if crews must leave a hospital prior to posting their final required report as called for in the general EMS Rules. We already had a "Covid-19" paper PCR approved in March of 2020. We've updated that report for current use as the temporary PCR allowed in the emergency rules and it was approved yesterday by the System Advisory Board for immediate use. <b>See Attachment.</b>
Bypass policy	Bypass policies will be updated again based on the new emergency rules. Discussing with our Region 9 partners now. Stay tuned
