RE: Update to Controlled Substance Log

Background: Drug Distribution Secrity Requirements

On August 25, 2023, the U.S. Food and Drug Administration (FDA) announced compliance policies for Drug Supply Chain Security Act (DSCSA) enhanced drug distribution security requirements that were scheduled to go into effect November 27, 2023. The compliance policies state that FDA will not take action until November 27, 2024, to enforce requirements in Section 582(g)(1) of the Federal Food, Drug and Cosmetic Act (FDCA), including the requirements to include product identifiers in the transaction information for each transaction and to exchange transaction information and the transaction statement in a secure, interoperable, electronic manner in accordance with FDA guidance. Further, FDA stated it would not enforce the requirement that the product identifier be included in the transaction information for any product introduced in a transaction into commerce by the product's manufacturer or re-packager before November 27, 2024.
